#### **OFFICE ORDER**

Consequent upon the interview held on 29-09-2025, the following doctors (Supplementary Session Graduates of AIMC, Lahore (2025) have been selected for appointment as House Officer on paid basis in Jinnah Hospital, Lahore for a period of one year with effect from 11-10-2025 to 10-10-2026 in the Wards/Departments as shown against their names on the following terms and conditions.

#### **TERMS AND CONDITIONS:**

- The appointment as House Officer shall be governed under the provisions of House Job Policy issued by Specialized Health Care & Medical Education department. Government of the Punjab vide notification no. S.O (ME) 2-26/2010(P) dated 17th September 2020.
- 2. No house officer is allowed to replace duties with any other person under the disguise of Locum/replacement from outside the ward. In extreme exigency, duty can be replaced with the fellow HO of same ward of same module for not more than 3 hours.
- House Job is full time, residential one year job required for issuance of full registration with PM&DC. Any person found absent from duty shall stand terminated without any notice & no leave of any kind is allowed in the period of house job.
- 4. Any person who stands terminated on account of violation of provisions of terms & condition of appointment shall become ineligible to undertake further house job at this hospital & no Experience Certificate shall be issued.
- 5. Any unauthorized person/outsider or HO from other ward found performing duties as locum shall be deemed to commit fraud & criminal action/FIR may be launched against such culprit & beneficiary HO shall stand terminated without any notice.
- 6. They will be required to stay in the Hospital and be available for duty round the clock and will leave the Hospital only after obtaining written permission from the Medical Superintendent. They will observe Hospital/Office timing and code of discipline during the period of House Job.
- 7. They will have to deposit with the Hospital Cashier a Sum of Rs. 1000/- as security, which will be refundable on the production of No Due Certificate after the completion of the House Job. Experience Certificate will be not be issue to the House Officer who leaves the job without completion of tenure, Hospital security will also be forfeited.
- 8. They will have to deposit with the Hospital Cashier a Sum of Rs. 1000/- as security, which will be refundable on the production of No Due Certificate after the completion of the House Job. Experience Certificate will be not be issue to the House Officer who leaves the job without completion of tenure, Hospital security will also be forfeited.
- Stipend will be paid for the period of actual work done in the Wards, after verification of attendances.
- 10. They will be bound to obey Rules and Regulations and orders issued by the authority from time to time. The Experience Certificate will only be issued on the provision of PMDC Registration Certificate.
- 11. They will be paid (fixed stipend for Regular House Officers) vide Government of the Punjab, Health Department, letter No. FD.SR.J-9-34/2012 (N.D) (A), dated 09.07.2012.


