In order to complete the admission process, the newly selected MBBS students are required to submit the following Original Documents alongwith photocopies, failing which will lead to the cancellation of their joining to the session 2025-26 at Allama Igbal Medical College Lahore.

- 1. Secondary School Certificate (SSC / Matric Certificate/ O-Level / Equivalence Certificate) attested by the IBCC alongwith three-03 attested copies.
- 2. Intermediate / HSSC / A-Level / Equivalence Certificate or detailed marks certificate of F.Sc (Pre-Medical) attested by the IBCC alongwith three-03 attested copies.
- 3. Provisional Certificate / Character Certificate of college last attended alongwith three-03 attested copies.
- 4. Domicile Certificate along with three-03 attested copies.
- 5. Board Migration Certificate (NOC) in case of F.Sc is federal board or other than Punjab along with three-03 attested copies.
- 6. Five-05 latest passport size photographs (sky blue background) without attestation.
- 7. CNIC / NICOP / POC / B-Form / CRC / Passport / Visa etc; three-03 attested copies (original not required).
- 8. MDCAT Certificate alongwith five attested copies.
- 9. AIMC digitalization portal QR coded (i.e. Activity / Medical Examination / College ID proforma) printout.
- 10. A copy of UHS admission application.
- 11. Certificate that you have been vaccinated against Tetanus, Measles, Mumps & Rubella for (Girls)
- 12. Certificate that you have had a full course of immunization against Hepatitis 'B', and Inoculated against the enteric group of fevers within the preceding 12months.
- 13. Foreign students will have to produce a certificate of their HIV status from prescribed laboratories in Pakistan.
- 14. A certificate / letter of relieving issued by the previous institution and Affidavit worth Rs.100/- by the candidate previously admitted in any medical/dental institute of the country (Affidavit No.1 specimen enclosed).
- 15. Affidavit worth Rs.100/- (Affidavit No. 2 specimen enclosed) duly attested by Oath Commission.
- 16. Surety Bond (specimen enclosed) on an E-Stamp paper of minimum worth Rs.1200/- duly attested by the Civil Judge / 1st Class Magistrate.
- Please submit all your documents in a plastic bag, write the candidate's name, father's name and third college-wise merit serial number on it with a bold marker.
- The selected candidates are advised to upload the clear and readable scanned images of their original documents at AIMC Digitalization Portal (https://aimc.pythonanywhere.com) in JPG/JPEG/PNG format, with a maximum file size of 1 MB per documents. For documents scanning purpose, you can use scanning machine or applications such as CamScanner.
- Please keep with you at least 10 copies of your each document i.e. Matric, Fsc, Domicile, Character Certificate & five passport size photographs before depositing them in Student Section of AIMC.
