  3. Provisional Certificate/Character of college last attended alongwith five attested copies.
  4. Domicile Certificate along with five attested copies.
  5. Board Migration Certificate (NOC) in case of F.Sc is federal board or other than Punjab along with five attested copies.
  6. Ten latest passport size photographs (sky blue background) without attestation.
  7. CNIC / Form B five attested copies (original not required).
  8. MDCAT Certificate alongwith five attested copies.
  9. Certificate that you have been vaccinated against Tetanus, Measles, Mumps & Rubella for (Girls).
  10. Certificate that you have had a full course of immunization against Hepatitis 'B', 'C' & Corona Virus.
  11. Deposit Remaining College fee for the session 2022-23 i.e; **Rs.18,425/- (only for Open Merit, Disable & Overseas categories)** and Hostel fee **Rs.52,740/- (for all categories)** in HBL AIMC Branch.
  12. Surety Bond (specimen enclosed) on a E-Stamp paper of worth Rs.100/- duly attested by the Civil Judge/1<sup>st</sup> Class Magistrate & Affidavit (specimen enclosed) duly attested by Oath Commission.
